JLC has a broad experience with different forms of teaching and with teaching different topics. The primary, recent teaching activities for JLC has been within Innovation and Entrepreneurship.

He teaches courses at both bachelor level and master level. In the academic year 2015-16 he has organised and taught the courses Innovation and Entrepreneurship at the 6th semester, bachelor education in Business Administration, and at the MIKE-program (Master in Innovation, Knowledge and Entrepreneurial Dynamics) the course in 'Executing Entrepreneurial Ideas'.

He regularly supervises semester Projects and master thesis.

JLC is regularly the supervisor for Ph.D. students. He is currently the supervisor/co-supervisor of two Ph.D. students. In addition, he has for years taught and organised a 5 ECTS Ph.D. course 'Entrepreneurship and Innovation Theory' held each year in april and organised within the Doctoral School of Organisation and Management (DOME), which is a cross-institutional collaboration between three Danish universities.

He has often participated as opponent in PhD pre-defences or in Ph.D. assessment committees, and is a regular participant and active opponent in the yearly DRUID Academy Ph.D. conference.
