My teaching activities at AAU primarily takes place within the criminology and sociology educations. At the criminology education I teach and supervise master's students, and I contribute to the bachelor's education in sociology.

In the criminology program I contribute to several courses. These include five lectures in the course of criminological theories, one in the course on qualitative methods, and two in the course on current criminological problems. I also organize and supervise seminar exercises. In broad strokes, my teaching revolves around topics such as criminological theory, online ethnography global, transnational and cybercrime. Moreover, I supervise project work, internships and master's theses within the criminology education. Within the bachelor's education in sociology, I coordinate and teach in the elective course on criminology. I also introduce the study of crime during the 1st semester. Moreover, I supervise quantitative semester projects on the 5th semester. Finally, I am also a department supervisor in the University Pedagogy Program.

I coordinate the elective course on criminology in the within the bachelor's program in sociology. I am also part of the AAU employability effort within the criminology education, where I work to strengthen the employability of graduates. Among other things I have organized a series of public webinars where students present their semester and theses projects. Finally, I am a member of the Study Board of Sociology and Criminology.
