Faculty development

Innovation of the educational environment In Aalborg University hospital, "3-hour meetings" provide junior doctors with three hours within normal working hours for discussing training with an innovative purpose. The meetings are followed-up by dialogue and action throughout the organisation. The junior doctors get many of their training initiatives implemented.

The Head of Department obtains information, which is used for prioritisation of educational initiatives. At hospital level, an overview of education as well as sharing of knowledge and educational vision is achieved. I have been in charge of this process since 2005 and I am author/co-author of several publication regarding this process and its results.

Teaching of faculty.

Specialist training and medical pedagogical methods I have been in charge of teaching/dissemination of factual knowledge about the specialist training and medical teaching methods at individual, group, department and hospital level. For example in relation to the network of educational key players. I have arranged meetings for doctors responsible for postgraduate training at the different department at the hospital (UAO) and the coordinating junior doctors (UKYL).

Two annual half-day thematic meetings with opportunity for debate in the network. Coordinating junior doctors (UKYL) is also invited. Examples of content are shown below:

Management of education I am involved in the overall strategic planning of postgraduate training at hospital level and in dialogue with all departments/specialties at Aalborg University Hospital. In cooperation with the hospital management, I have built up an organisation of postgraduate education, including the establishment of an educational committee (DPU) and network between "Consultants responsible for postgraduate medical education" (in Danish "Uddannelsesansvarlige overlæger", UAO) and coordinating junior doctors (in Danish, UKYL) (> 100 people).
