Type Student evaluations of teaching has generally shown an average in the range of 'satisfactory' and 'very satisfactory' concerning supervision and courses. The course in Mobility of Sociology (2005-2016) and Mobility and Transport Planning (2017-present) has consistently shown 'very satisfactory'.

Was in 2020 nominated on the basis of the teaching in the course Mobility and Transport Planning for Teacher of the Year at the Study Board for Planning and the Land Inspectorate. The motivation was as follows (in Danish):
